Three residents from Meadow Street have put in a request for reimbursement for sidewalk replacements. The spokesperson for the residents is John P. Giovacchino who resides at 28 Meadow Street. He is aware that after the work is done and then inspected by the Town then they will receive their 1/3 reimbursement from the Town. The Town Counsel has reviewed all of the quotes and the request and everything is in order. The low quote is from Teodosio &

Sons Construction Company, LLC from 6 Riverside Drive, Ansonia, CT 06401. It is \$5,350.00 for 28 Meadow Street, \$2,500.00 for 24 Meadow Street, and \$1,475.00 (apron only) for 18 Meadow Street for a total of \$9,325.00.

John Putorti: States that he represented the Town at the Veterans Day ceremony at French Park on November 11, 2008. He says it went very well and there were many people in attendance including 2 buses full of High School Students, who brought 30 boxes of donations for the VA Hospital.

Paul Roy: He attended the Veterans Day ceremony at the Broad Street Park that was held on the evening of November 11, 2008 and was arranged by Al Yagovane. There were also many in attendance including Mayor DellaVolpe from Ansonia and Bill Paecht and many residents. Mr. Yagovane did a great job.

John Conroy: Attended a meeting at the High School concerning getting more kids enrolled/interested in the tech trade classes. Approximately 20% of students go into a trade after High School. There is a Perkin Grant available for this. There were many in attendance including the Valley Chamber members, school officials, and business from the Industrial Park looking to recruit workers. The meetings will be held approximately every 3 months. Mr. Conroy also discusses the "Water Main Break", which occurred on Monday morning at approximately 6:30 AM. This shut down water to most of the Town for some time on Monday, but was repaired by Tuesday morning. The CODE RED system was implemented for the first time alerting residents from the Skokorat Street area to the South Main Street area, which has received a positive response from many. It actually encouraged more people to sign up.




