### **Strand Theater:**

Manager Jeri Swinik not in attendance report given by Priscilla Altorelli

New Popcorn machine purchased at a cost of \$725.00  
\$3,388.00 ticket sales \$1,687.00 concession sales for August 2008

Jeri Swinik reminded the Commission that price increases for the theater were really needed. Since our last month's meeting her delivery charges for the weekly film and the pick-up costs had doubled due to gas increases.

Jeri will be notified by letter that the increases will be as follows:

Theater tickets will increase to \$4.50

Candy / popcorn will increase to \$3.00 each

soda \$2.50 and water \$2.00 will remain the same, no increase at this time.

**Christmas Carolers:**


Carolers have been booked for the First Saturday in December
