BOE member Mr. Baker called the meeting to order at 8:06 p.m. explaining that the agenda called for the Board to consider and act upon a recommendation from the administration regarding a student expulsion.

10-E011 MOTION: (Mr. Loda sec., Mr. Kubik) move that the Board enter Executive Session to discuss a matter that would result in the disclosure of public records or the information contained therein as described in Connecticut General Statutes Sections 1-210(b)(2), (11) and (17). In addition to the Board members, all those mentioned in the above motion met in executive session. The Board Members along with Attorney Dorsey entered into deliberations at 8:58 p.m.

The Board entered into regular session at 9:01 p.m.

10-E012 MOTION: (Mrs. Loda, sec., Mr. Kubik) move that pursuant to Connecticut General Statutes Section 10-233d, Seymour Board of Education shall expel the student discussed in executive session from attendance at Seymour High School for the period from November 5, 2010 until November 4, 2011 with the opportunity for the reasons presented by the administration in this hearing.

Further, the Board directs the administration to offer an alternative educational opportunity to the student for the period of this expulsion, pursuant to Connecticut General Statutes Section 10-233d(d) in the form of tutoring as determined by the administration.

The Superintendent is also authorized to allow early readmission no later than the beginning of the second semester of the 2010-2011 school year if the student meets the following conditions: : 1) the student must have passing grades in all subject areas in order for early return; 2) the student will not be able to participate in any extra curricula activities such as dances, field trips, proms, athletic events, until the end of the 201-2011 school year; 4) from the date of the expulsion until the end of the school 2010-2011 school year the student must perform 20 hours of community service in a program as approved by the Superintendent; 5) from the beginning of the second semester until the end of the school year, if the student returns early, the student must maintain passing grades in all subjects; 6) from the beginning of the second semester until the end of the school year, if the student returns early, there must not be any serious referrals as determined by the Superintendent; 7) the student's parents must schedule a meeting with the Superintendent during the second week of June 2011 to discuss meeting these criteria; 8) if all the criteria are met as determined by the Superintendent, the probationary period will end and not be carried forward into the 2011-2012 school year; 9) if the student does not meet the criteria of the probationary period as determined by the Superintendent, the Superintendent is authorized to reinstate any unserved portion of the expulsion without further action by the Board of Education.

The Board further directs the administration, pursuant to Connecticut General Statutes Section 10-233d(f), to record this expulsion on the student's cumulative educational record, to be expunged from such record if the student graduates from high school.

Finally, the Board authorizes Bruce Baker and Attorney Frederick L. Dorsey to communicate in writing to the student's counsel and/or his/her parents, as appropriate, the Board's decision and the reasons therefore, consistent with the Board's executive session discussion.
