The meeting was called to order at 7:30 p.m. by Phil Wilhelmy.

Enforcement Officer Report

Mr. Conroy spoke on the situation at William Lane and stated that included in the packets that the members have are the minutes from the January 28th meeting when they were given permit to make the crossing. Also included was the timetable from them as to how long it would take them to do the crossing, which was four weeks. It is now almost September and they haven't completed the crossing.

Mr. Conroy stated that in response to what is happening on William Lane with the soil and erosion controls and the time span that it has taken, he issued a cease and desist to the owner on August 6th and on August 8th the fine of \$150.00 a day went into effect. He stated that he is assessed that fine seven days a week until the problems are all corrected.

He stated that they have had two or three job meetings on William Lane. He stated that the town engineer has been there as well as his engineer, Don Smith and his attorney, Fran Teodosio. At the latest meeting they were given until September 5th to either make the necessary corrections to the site or else they are going to consider removing the site contractor that they are using and hire a new site contractor. Mr. Wilhelmy asked if the fine was going to continue to September 5th and Mr. Conroy stated that it is going to continue until the site is fixed.

Mr. Smith gave a date of October 15th that the road would be paved. Mr. Conroy stated that he did not want the road to go unpaved through the winter. He stated that some work has been done in the last few days but he wants to see what is done by the 5th, at which time a meeting will be held at the site.

Mr. Conroy stated that he received a complaint about 152 Bungay Road. Mr. Wilhelmy read the permission letter from the property owner giving the Wetlands Inlands Commission to come onto his property at 152 Bungay Road dated August 14, 2008. Mr. Conroy stated that he has no permit or application. Mr. Conroy stated that there is anywhere from 3500 to 4500 yards of fill that has been brought to the site without a permit. He stated that it is, at the closest point about 12 feet from the brook. He felt that it is sitting on wetlands. He has not done any more work on the site and has been

instructed to file an application. Mr. Wilhelmy stated that the Commission will look at it and he is in the process of filing an application for the September meeting.


Mr. Conroy stated there is a site at 99 Tomlinson Road where a parking pad was put in. He built a retaining wall close to the brook. It is a permeable surface that is put in and the only concern may be with runoff from the cars going into the wetlands. It was suggested that more crushed stone be put around the pipe. Mr. Conroy asked the members to look at the site and see if they feel that the wall is too close to the wetlands. Mr. Wilhelmy felt that he should come in and get a permit. Mr. Conroy was concerned because he feels that he may continue the wall. Mr. Conroy stated that he will inform him to come to the next meeting with an application. Mr. Ryan felt that they should look at the site and then decide if the owner needs to come in with an application.
