Richard Grudzias to accept Item #3 second by Patrick Lombardi. No comments.


Moderator asked for a vote at this time on Item #3.

94 in favor of item #3. 0 Opposed. 0 Absentions.


Moderator Kulas to accept a motion to adjourn. Philip Wilhelmy to adjourn second by Karl Trybus.
